The Innovation Planning Grant Application (Form SL-400) is now available. Review the information below to access the form and submit your application to the Wisconsin Department of Revenue (DOR).

- If you don't have access to MyDORGov, set up your account by following the below steps

MyDORGov – Account Setup

1. The first time you enter the system, you must complete an email authorization
2. Enter your email address and click "Login"
3. You will receive an email with a link to access MyDORGov
 - This access remains in effect for 30 days
 - If you do not access the system for 30 days or access the system from a different computer, you will be prompted to complete the email authorization process
4. If requested, enter your contact information. DOR will use this contact information to send notifications for the entity you represent.

Accessing My DOR Government Account – email authorization:

For added verification, the Wisconsin Department of Revenue (DOR) utilizes email authorization to begin a filing session. You must enter an email address to receive a link before you can file.

Accessing My DOR Government Account

- Once you click the Login link in your email, you are directed to My DOR Government Account where your forms are located
- You can access My DOR Government Account from the same computer and browser anytime within 30 days. Once you access My DOR Government Account, it resets your 30-day window.
- If you do not access My DOR Government Account within 30 days or if you delete your browsing history (cookies), you must reenter your email address to generate a new link

Note

- Use the same computer and browser to access My DOR Government Account. If you would like to use a different computer, you must reenter your email address to receive a new Login link.
- Because your email is registered in our system, you do not need a password to access My DOR Government Account

User Information – Request Office

1. On the "user information" page, click "Request Office" at the top of the page
2. Select "Tribal Government" from the Office dropdown list
3. Enter your tribe name in the "District/company" field and select the pre-filled name that appears
4. Add an explanation in the "Comments" box
5. Click "Send" to send an email to DOR for approval
6. DOR will notify you by email within 10 business days. If approved, you can log into MyDORGov and begin filing. If denied, contact information will be provided for you to follow-up on the decision.
