e-Services: Are you aware that as a CPA or Enrolled Agent you can request and receive online transcripts, W-2s and 1099s within seconds through the Transcript Delivery System (TDS) and/or resolve a client's account problems online through the Electronic Account Resolution (EAR)? You can also complete a power of attorney online through Disclosure Authorization (DA). You can have unprecedented access to these IRS incentive products that allows you to assist your clients in a fraction of the time it currently takes. These services are available 24 hours a day, 7 days a week from your computer.

My Tax Account: Are you aware that there is a new online filing system for businesses called "My Tax Account?" You can now file and pay your clients' business taxes and view their accounts online at the Department of Revenue. You can also view any mail they have received from the Department of Revenue, any returns filed, any payments made, and any items that need attention by you. It's simple, secure and available 24 hours a day, 7 days a week from your computer.

IRS will cover e-Services registration, delegating e-Services to other employees in your firm, updating your ERO application online, password management, and how to access and use the e-Services incentive products (DA, TDS and EAR).

WI Dept. of Revenue (WIDOR) will be promoting the new online filing system for businesses, "My Tax Account". The presentation will also include information on electronic mailing lists for DORNews and DORSales.
