<b>b</b> Enter 2024 refundable credits (excluding estimated tax and surcharge paid) . . . . .				
<b>c</b> Subtract line 1b from line 1a . . . . .				
<b>d</b> Wisconsin tax withheld for 2024 . . . . .				
<b>e</b> Subtract line 1d from line 1c. If less than \$500, enter \$0 and go to Part II if applicable . . . . .
